






That following consultations among stakeholder including parliamentary committees, it was confirmed that NICOL did not have any financial obligation or indebtness to TMCL.

That, the Building, Machineries and operation of the subsidiary company **(TMCL)** were confiscated by the Government on 27 November 2019, and therefore, NICOL lost control of TMCL

NOW THEREFORE, the Shareholders of NICOL resolve as follows:-

Steps be taken to safeguard the interest of NICOL in the process of liquidation or dissolution of the company.

"RESOLUTION NO. 9/2020"

NICOL should negotiate with minority shareholders to ensure that the relinquishing of NICOL shareholding in TMCL is concluded amicably and in the interests of both parties.

**"RESOLUTION NO. 10/2020"** 

In implemented this Resolution all efforts should be undertaken to comply with the Regulatory and legal procedures.


